## 1. Introduction

The aim of this factsheet is to provide a short and focused overview of the issues you need to be aware of prior to importing goods from outside the UK and/or exporting overseas.

Before you start importing or exporting goods you need to ensure that the products are classified under the correct commodity code. This is an eight-digit (for exports) or ten-digit (for imports) number that determines the applicable duty rates and any import/export restrictions and is also used on all customs documentation.

HM Revenue & Customs also runs a Tariff Classification Helpline where an adviser can assist you in determining the correct commodity code for your goods and you can also obtain legal confirmation of the code for your product. The helpline can be reached at: 01702 366 077.

## 2. Trading within the EU

For goods coming into the UK from any of the other 26 EU member states there are no import tariffs. However, the imported goods will be subject to VAT and, for some products, also excise duty. The VAT will be collected when you submit your annual VAT claim to HM Revenue & Customs.

For goods manufactured outside the EU, once they are legally imported into any EU country there are no further customs controls and the goods can freely circulate within the single European market. During transportation you will only need to ensure you have a commercial invoice which clearly indicates the origin of the goods. In addition, the Single Administrative Document (see below) is used to help confirm origin of the goods.

## 3. Importing from non-EU countries

The Single Administrative Document (also known as the C88 in the UK) is used for import declarations when trading with non-EU countries and for the movement of non-EU goods within the EU. The import duty and VAT are payable as the goods enter the UK. The import duty is determined from the value of the goods on the commercial invoice, insurance and cost of freight. VAT is charged on the total including import duty.

Most goods can be imported into the UK without any restrictions, however in certain instances an import licence may be required. These include imports of firearms, plants and animals, foods, medicines, textiles and chemicals. The licensing requirement may also depend on the country of origin of the product. The competent agency responsible for issuing any licence depends on the type of product (for example Food Standards Agency, Health and Safety Executive, Rural Payments Agency, etc.).

## 4. Exporting to non-EU countries

The Single Administrative Document is used for export declarations when trading with non-EU countries and for the movement of non-EU goods within the EU. Usually the freight forwarder takes the responsibility for all customs documentation and export processes.

Some goods may be subject to export restrictions or require an export licence. These include military or paramilitary goods and technology, dual-use goods, artwork, plants and animals, medicines and chemicals. The licence requirements may also depend on the country of destination of the product. The Export Control Organisation, part of Department for Business, Innovation and Skills, advises businesses on the 'controlled' goods and issues the required licences for military and dual-use items. ## 5. Government support for exporters

The UK government provides a variety of schemes that aim to encourage British companies to export overseas. The **Export Credits Guarantee Department** (ECGD) provides insurance for exporters against non-payment by their overseas buyers, guarantees for bank loans for overseas buyers of UK goods and/or services and insurance against political risk for investments outside the UK. The UK Trade and Investment (UKTI) offers a wide range of support for exporters mostly focusing on advice, market research and financial support. The three main programmes include:

- **Passport to Export:** A range of subsidised services including export health check, export advice, market visit support, quality training, etc.
- **Tradeshaw Access Programme:** Grants to small and medium sized enterprises to attend trade shows and exhibitions abroad
- **Export Market Research Scheme:** Grants to subsidise the costs of export market research

### Research and Enquiry Service

### Business Cooperation Database

This consists of a Europe-wide database of company profiles, all of whom are seeking or offering cooperation with foreign partners in their specific sectors. Typically this includes joint ventures, acting as a subcontractor or distributor. Common requests can include finding an agent in a specific business sector, or finding manufacturers in another EU country.

### Events

The London Chamber of Commerce's series of international seminars is designed to help businesses to fully benefit from international trade. A regular programme of specialist seminars, focusing in depth on specific overseas markets for UK exporters is operated.
